Paper? Pass. \$250 Switch & Win Sweepstakes Entry Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THE SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

The REC "Paper? Pass. \$250 Switch & Win" Sweepstakes begins at 12:01 a.m. Eastern Time (ET) on September 1, 2026, and ends at 11:59 p.m. ET on September 30, 2026.

This Sweepstakes is open only to persons who are legal U.S. residents, with a residency in the Commonwealth of Virginia and are 18 years of age or older at time of entry. Business entities are not eligible to participate in this Sweepstakes. Officers, directors, managers and employees, including immediate family members (spouse, parent, child, sibling and their respective spouses within the same household) of Rappahannock Electric Cooperative, its respective parent, subsidiaries, affiliates and related companies are not eligible to participate or win a prize. This Sweepstakes is subject to all federal, state and local laws and regulations. This Sweepstakes is void outside the Commonwealth of Virginia and wherever else restricted or prohibited by law.

Two prizes of a \$250 gift card, with an Approximate Retail Value of \$250 each and \$500 for Sweepstakes total, will be awarded to the prize winners. There will be one random drawing held on Oct. 8, 2026, in which two prize winners will be selected at random from among all eligible entries received during the Sweepstakes period. Odds of being selected as a prize winner in the drawing are dependent upon the total number of eligible entries received. The prizes cannot be substituted, assigned, transferred, or redeemed for cash; except at REC's sole discretion or as otherwise provided herein. REC reserves the right to substitute the prize with a prize of comparable or greater value if advertised prize should become unavailable. REC will not replace any lost or stolen prize. Prize winner is solely responsible for any taxes on the prize he/she has received, including but not limited to any and all federal, state and local taxes. Prizes will be awarded within six to eight weeks from the date the prize winners are confirmed. The name of prize manufacturers / trademark owners is used solely for the purposes of identification of the prize. No endorsement, authorization, sponsorship, or approval of prize manufacturers / trademark owners is intended or implied by such use. Potential prize winners consent to REC's use of their names, likenesses, biographical information, and voices in advertising worldwide without additional notice or compensation.

There are three ways to enter the Sweepstakes; however, regardless of the method used to enter the Sweepstakes, either via existing and new paperless billing registration or AMOE (defined below), the maximum number of entries allowed during the Sweepstakes period is one per person.

Existing REC members who registered for paperless billing of their REC accounts through the MyREC SmartHub or other method prior to September 1, 2026, will automatically receive one entry into the Sweepstakes.

New paperless billing members entering the Sweepstakes via online entry or other method must be a new or existing REC member during the Sweepstakes Period. To receive an entry into the Sweepstakes via online entry, members must register for paperless billing during the Sweepstakes Period through an existing or new profile on MyREC SmartHub. New and existing REC members may enter online as follows: To register an online account via MyREC SmartHub, visit www.myrec.coop/myrecsmarhub during the specified Sweepstakes period and select Sign Up. Then, create your account by submitting all the information requested. NOTE: You will need a valid email address, your REC account number, last four digits of your Social Security Number, and zip code to create your account.

Members may also enter this sweepstakes by enrolling for paperless billing by calling Member Services at 1-800-552-3904 during office hours.

Alternate Method of Entry ("AMOE") without requiring membership with REC and/or registration of an account online, may be submitted as follows: On a plain 3" x 5" card, legibly handprint or type your first name, last name, complete address, city, state, zip code, home phone number (including area code) date of birth, and email address; and mail your completed 3" x 5" card to: "Paper? Pass. \$250 Switch & Win Sweepstakes", P.O. Box 7388, Fredericksburg, VA 22404. Each envelope shall equal one entry. Limit of one entry by mail per person during the Sweepstakes period. Entries must be postmarked by September 30, 2026, and received by October 6, 2026. Multiple entries submitted by a single entrant or in the same envelope are void. Entries submitted or completed by anyone other than the named entrant are void. No mechanical reproductions will be accepted. REC will not verify receipt of entries for AMOE entrants. All entries submitted become the sole property of REC and will not be returned. REC is not responsible for lost, late, misdirected, illegible, damaged or postage-due AMOE entries.

Regardless of the method used to enter the Sweepstakes, the maximum number of entries allowed during the Sweepstakes period is one per entrant. Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different email addresses, telephone numbers, identities, and/or any other methods will void that entrant's entries, and that entrant may be disqualified from the Sweepstakes. In the event of uncertainty as to the identity of an entrant entering via the new paperless billing enrollment method, the entrant will be deemed to be the first named person of the REC account. Limit of one prize per person.

The random drawing decisions are based upon REC's discretion and interpretation of these entry rules and are final and binding in all respects. A prize winner who entered the Sweepstakes via new paperless billing enrollment must still have an active online account upon selection, subject to verification. A prize winner who entered the Sweepstakes via new or existing paperless billing enrollment must have an account in good standing upon selection, subject to verification. The potential prize winners will be notified by e-mail upon electronic award of his/her prize. In the event a prize is returned as undeliverable, the prize will be considered forfeited, and an alternate prize winner will be selected at random from amongst all remaining non-winning eligible entries received in the Sweepstakes period.

Should any portion of the Sweepstakes be, in REC's sole discretion, compromised by non-authorized human intervention or other causes which, in the sole discretion of REC, corrupt or impair the administration, security, fairness or proper play, or submission of entries, REC reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Sweepstakes and conduct the Sweepstakes in a manner which in its sole discretion is fair, appropriate and consistent with these entry rules. Notice of such action by REC will be posted at www.myrec.coop/paperless. In such event, REC reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment. REC reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these entry rules or in an unsportsmanlike or disruptive manner. REC reserves the right to disqualify or reject any incomplete, inaccurate or false entry.
