# \$12.5 Million - in Capital Credits Coming to Member-Owners

Look for your cash back credit on this month's electric bill.

The longer you have received electricity from REC, and the more electricity you have used during that time, the larger your Capital Credits return will be.

The Board voted to return \$12.5 million in Capital Credits, which is money left over after maintaining and delivering reliable electric service. As a not-for-profit cooperative, a portion of those Capital Credits are retired and returned to members over time.

It's another way your cooperative is focused on you.



# New Rate Increase Takes Effect In July

Like nearly everything else, from groceries to gasoline, from used cars to hotel rooms, natural gas prices have increased dramatically this year. Natural gas is used to generate roughly 40% of all electricity provided in this region, and since the beginning of this year prices have roughly doubled.

As a result, Old Dominion Electric Cooperative (ODEC), REC's primary power supplier, has implemented a second price increase to account for higher generation costs. Along with 10 other electric cooperatives in Virginia, Maryland and Delaware, REC is a partial owner of ODEC.

What to expect: A typical residential household that uses nearly 1,350 kWh of electricity each month will see an increase of about \$4.57 per month.

This increase is in addition to a similar increase resulting from higher generation costs that took effect as of bills issued in May.

"Unfortunately, the electric industry continues to see the same price increases that are plaguing so many other parts of our economy right now," said Brian Doherty, Managing Director — External Affairs at REC. "As a result, we expect to see additional increases this year. We will communicate these increases to you as soon as possible.

"The increases are similarly impacting other electric cooperatives and investor-owned utilities in Virginia and across the country. We recognize every dollar matters, and we want to remain as transparent as possible while providing you with reliable and affordable electricity.""
